Fund Update for the year ended 31 March 2024

This fund update was first made publicly available on 3 July 2024.

What is the purpose of this update?

This document tells you how the Automatic Fund (Age 40) has performed and what fees were charged. The document will help you to compare the fund with other funds. Local Government Superannuation Trustee Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Automatic Fund is a life cycle investment option. Its objective is to try to achieve an appropriate long-term outcome for investors by accepting a higher investment risk and return volatility in the early stages of a member's working life as a trade-off for potentially higher returns.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the



How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


lan had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year lan received a return after fund charges were deducted of \$1,289 (that is 12.89% of his initial \$10,000). Ian also paid \$72 in other charges if he wasn't employed by a Participating Employer². This gives Ian a total return after tax of \$1,217 for the year (or \$1,289 for the year if he was employed by a Participating Employer²).


What does the fund invest in?

Notes

- 1. The fees charged include an estimate for in-fund costs which are fees and expenses recovered from the underlying funds we invest in by the respective fund managers. The in-fund costs are not fixed as the actual amount of these costs will vary slightly from year to year based on average balances. This means that this component of the annual fund charges can only be estimated.
- 2. Currently no administration fee is payable by members who are making payments via their Local Authority Employer (Participating Employer).
