## Fund Update for the year ended 31 March 2024

This fund update was first made publicly available on 3 July 2024.

## What is the purpose of this update?

This document tells you how the Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Local Government Superannuation Trustee Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Balanced Fund target asset allocations are 50% in growth assets and 50% in income assets. The investment objectives of the Balanced Fund are to achieve positive real returns over the medium to long term through investment in a balanced mix of growth and income assets.

The risk indicator is rated from 1 (low) to 7 (high).



## How has the fund performed?


#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Ian had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Ian received a return after fund charges were deducted of \$942 (that is -9.42% of his initial \$10,000). Ian also paid \$54 in other charges. This gives Ian a total return after tax of \$888 for the year.

#### Notes

1. The fees charged include an estimate for in-fund costs which are fees and expenses recovered from the underlying funds we invest in by the respective fund managers. The in-fund costs are not fixed as the actual amount of these costs will vary slightly from year to year based on average balances. This means that this component of the annual fund charges can only be estimated.
