### Automatic Fund (Age 40)

#### Fund Update for the year ended 31 March 2026

This fund update was first made publicly available on 3 July 2026.

#### What is the purpose of this update?

This document tells you how the Automatic Fund (Age 40) has performed and what fees were charged. The document will help you to compare the fund with other funds. Local Government Superannuation Trustee Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Automatic Fund is a life cycle investment option. Each month, between the ages of 20 and 80, the Automatic Fund will automatically and smoothly change a member's target investments to a more conservative mix. Its objective is to achieve an improved long term outcome by accepting a higher investment risk and return volatility in the early stages of a member's working life as a trade-off for potentially higher returns.

#### What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

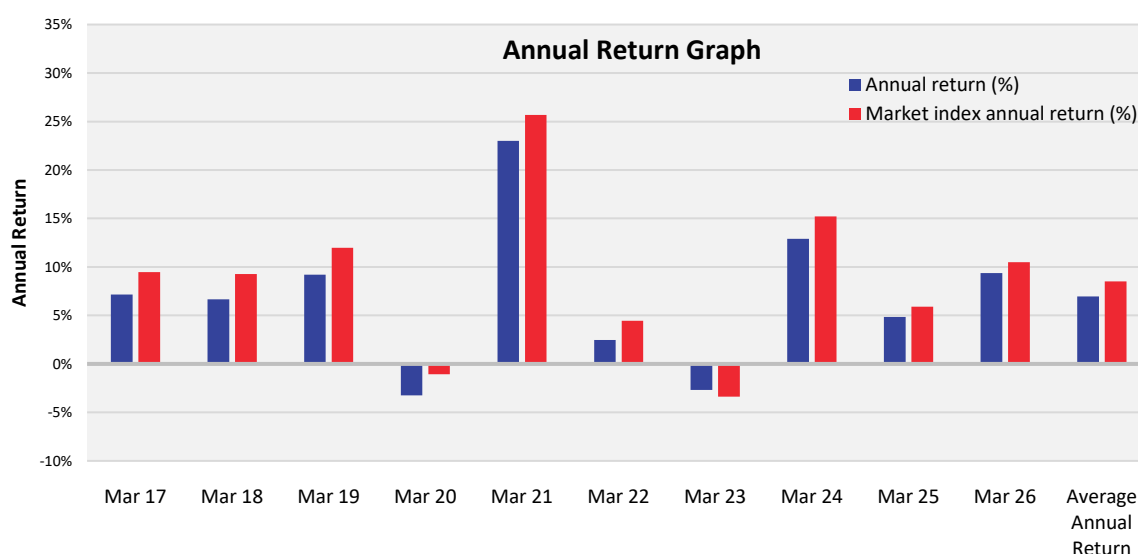

### Example of how this applies to an investor

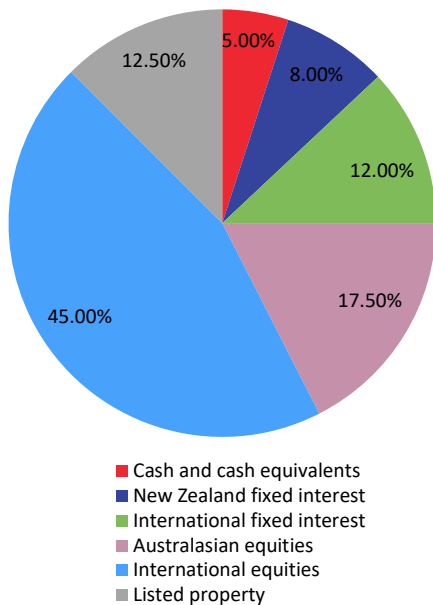
Small differences in fees and charges can have a big impact on your investment over the long term.

Ian had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Ian received a return after charges and tax of \$936 (that is 9.36% of his initial \$10,000, or \$1,008 for the year if he was employed by a Participating Employer<sup>2</sup>).

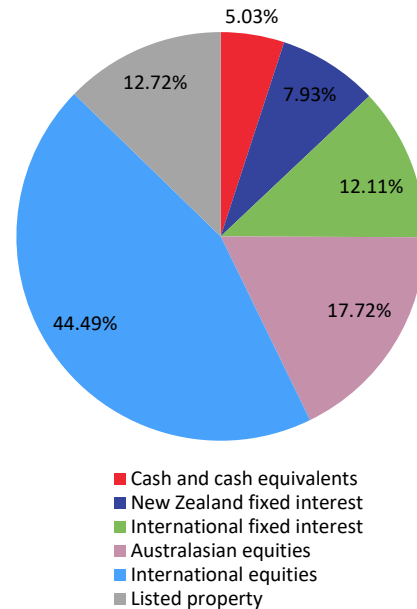
## What does the fund invest in?

## Notes
